

# 2020 ANNUAL REPORT of the Town of ATHENS, MAINE

Laurel (Bill ) Williams passed away on November 11, 2020 he was 100 years old. Bill was our oldest WWII Veteran and we were proud to have had him present at our Veterans Memorial Plaque Dedication ceremony that was held on Friday December 07, 2018 in The American Legion Room at the Academy Building. # Jared Golden Congress of the United States 2nd District of Maine

Dear Friends,

I hope this letter finds you safe and well. I know that this year has been challenging for many of our communities. In the midst of these challenges, it remains a privilege to represent you, and I appreciate the opportunity to update you on what I have been working on in Congress for the people of the Second Congressional District.

The coronavirus pandemic has made this year an especially difficult one. We've seen the struggles of small businesses, workers and families, hospitals, and states and towns. COVID-19 has been a serious threat to public health that requires a comprehensive, ongoing response. In March, Congress passed the largest of three bipartisan pieces of relief legislation, the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act was a \$2 trillion economic relief package to provide immediate assistance for some of those hit hardest by the pandemic. While an important start, many of the programs and benefits created by the CARES Act were set to expire by the end of 2020 at a time when COVID-19 cases were on the rise. That's why in late December, Congress passed another bipartisan bill to provide COVID-19 relief to small businesses and hospitals, the unemployed, and families struggling to put food on the table. However, the action Congress took at the end of 2020 cannot distract from its failure to act sooner. The unwillingness of many members of Congress to accept compromise throughout the fall left many Mainers struggling and led to a rushed process that produced a bill with serious flaws. In 2021, Congress needs to step up, come together, and lead the country through this pandemic and get our economy back on track.

There are a few bright spots that came out of the work done by Congress this year. As a member of the House Armed Services Committee, I helped advocate for a national defense bill that would include important priorities for American national security, Maine shipbuilders, and servicemembers and their families. The legislation authorizes a new DDG-51 Arleigh Burke-class destroyer to be constructed at Bath Iron Works and helps BIW compete for new work by encouraging a new multi-year procurement process for the DDG-51 Flight III. This funding bill also makes permanent new federal guidelines proposed by Senator King and me to allow Gold Star Families free admission to national parks and other federal lands.

I've been working to improve mental health services for veterans for years, and I led the Maine delegation's effort to address the need for long-term mental health substance abuse treatment for veterans in our state. This past fall the Veterans Administration announced we were successful. Construction starts next year on a new, 24-bed facility at Togus that will ensure Maine veterans won't be sent out of state to receive residential care for substance use disorder and associated mental health issues. This is one result that I am especially proud to deliver for my fellow Maine veterans.

As I reflect upon what I am most grateful for this year, I am especially glad to be able to share that my wife Izzy and I are expecting a baby in 2021. We are excited about this new addition to our family and look forward to the blessings ahead.

This period is challenging for Mainers as we all take steps to limit the spread of the coronavirus, protect our families and our communities, and lean on each other to withstand this pandemic and economic hardship. My staff and I stand ready to assist Mainers as we work through these challenges together. I look forward to continuing to work on your behalf in 2021.

#### Dear Friends.

2020 was a year unlike any in our lifetimes. Our state and nation dealt with unprecedented challenges--the coronavirus pandemic, ensuing economic fallout, and a prolonged, heavily divisive campaign season each took a significant toll on all of us. The worst part? In order to protect each other, we had to face these challenges in isolation. But a new year represents new possibilities; a chance to take stock of what we're grateful for and focus on the opportunities in front of us. As we reflect back on 2020, we will remember heartbreak and loss – but we cannot forget the shining rays of hope that broke through the darkness, reminding us all that better days are ahead.

Throughout the pandemic, my top focus has been on bridging the partisan divide in Washington in order to deliver desperately-needed relief for Maine people. Joined by colleagues last March, we pushed for bipartisan negotiations to produce a strong bill that helped fellow Mainers, businesses, and institutions weather this storm. In the weeks and months after the *CARES Act* passed, our team stayed in close contact with people throughout the state to determine how we should adjust our response to best support our citizens. Unfortunately, the aid provided by the *CARES Act* lapsed without Congressional action, leaving too many families and businesses in limbo. I never stopped pushing for a bipartisan relief bill and, after extensive negotiations, we ended the year on a good note by breaking the gridlock and passing new relief legislation. This new bill isn't perfect; in fact, it should just be the start our renewed response. As we enter 2021 with a new administration and new Congress, we must fight for additional legislation to help restore stability to our working families and rebuild our economy and public health infrastructure.

In the midst of this crisis, Congress did manage to accomplish a few successes that will outlast this awful pandemic. Among these was the *Great American Outdoors Act.* a bipartisan bill which was enacted into law in August 2020 and will help address a \$12 billion backlog at our national parks so future generations of Americans can enjoy these beautiful lands and create lifelong memories. Also, as we learn more about the recent hacks of our nation's networks, there is help on the way: 27 of the cybersecurity recommendations made by the Cyberspace Solarium Commission – which I co-chair with Republican Congressman Mike Gallagher– made it into this year's defense bill. While there is no guarantee that these provisions would have prevented the massive hack, they will certainly improve our cyber defenses.

Despite the challenges, I'm hopeful for the future. Vaccines are being distributed across our state — starting with our healthcare heroes, who have sacrificed so much throughout this unprecedented catastrophe and deserve our eternal gratitude. If there can be a silver lining from these challenges of 2020, maybe it will be this: I hope that, in the not-so distant future, we will be able to come together physically and we will be reminded of our love for each other. We have differences, without a doubt. But as Maine people stepped up to support each other, we saw again and again that our differences pale in comparison to the values we share. We are one state, and one community — and there is nothing we cannot or will not do for each other. Mary and I wish you a happy and healthy 2021. We can't wait to see you soon.

#### Dear Friends:

It is an honor to represent Maine in the United States Senate. I am grateful for the trust the people of our State have placed in me and welcome this opportunity to reflect on 2020, an incredibly challenging year for Maine families, small businesses, and communities.

When the pandemic struck, our country faced the specter of an overwhelmed health care system and devastation to our small businesses and the millions of people they employ. I immediately worked with Republicans and Democrats to pass multiple laws allocating approximately \$3 trillion to respond to this public health and economic crisis, including more than \$8 billion directed to Maine to support testing, schools, the economy, and other purposes — that is nearly double Maine's annual state budget.

I am especially proud of the bipartisan Paycheck Protection Program (PPP) I co-authored. This program has provided three out of four Maine small businesses with nearly \$2.3 billion in forgivable loans, which has helped sustain more than 250,000 Maine jobs. I have met thousands of Maine small employers and employees in all 16 counties who are surviving because of the PPP. As one small business owner told me, the PPP provided "exactly what we needed at exactly the right time." The PPP also allowed employers to maintain benefits, such as health care, during this challenging time. Another round of PPP is needed to sustain small businesses and their employees.

While the pandemic continues across Maine, our nation, and the world, I thank the first responders, health care professionals, teachers, grocery store employees, factory workers, farmers, truck drivers, postal employees, and so many others who continue to stay on the job during this difficult time. With the deployment of the first vaccines, better tests, and the incredible speed with which these life-saving responses were developed, I am hopeful we can emerge from this crisis in the next few months.

While providing relief to American families was my focus throughout 2020, other accomplishments include the passage of the Great American Outdoors Act, which provides full funding of the Land and Water Conservation Fund and addresses the maintenance backlog at our national parks, forests, and wildlife refuges. As Chairman of the Transportation Appropriations Subcommittee, in 2020 alone, I secured \$132 million to improve Maine's roads, bridges, airports, buses, rail, ferries, and seaports. Finally, as Chairman of the Aging Committee, I led the reauthorization of the Older Americans Act, which funds programs that improve the well-being, independence, and health of our nation's seniors and their caregivers, and I authored laws to reduce the cost of prescription drugs and protect individuals with Alzheimer's disease.

As the end of 2020 is approaching, I have cast more than 7,535 votes, never having missed one. In the New Year, my focus remains to work with colleagues to find common ground on policies to help support the health and safety of Mainers and the safe, responsible opening of our communities. If ever I or my staff can be of assistance to you, please do not hesitate to contact one of my state offices. May the coming year be a successful one for you, your family, your community, and our state.

#### 2020 Sheriff's Office Annual Report

As your Sheriff, it continues to be an honor and privilege to serve the residents of Somerset County. The men and women of the Somerset County Sheriff's Office are dedicated to protecting life and property. The Office of the Sheriff oversees the operations of the County Jail, law enforcement, court security, and civil process. Somerset County is approximately 4,000 square miles. The County is comprised of 27 towns, 6 plantations, and 83 unorganized townships. I remain the 2<sup>nd</sup> Vice President of the Maine Sheriff's Association. I was also appointed to the Board of Directors for the New England State Police Information Network and Maine's Drug Enforcement Agency.

Covid-19 has had a direct impact on our enforcement, Courts, civil processing, and Jail. Considerable time and resources has been spent purchasing PPE gear and developing and implementing Covid-19 safety measures to protect Deputies and Corrections Officers. The service of civil paperwork was suspended for approximately 3 months. We stopped in-person visits at the Jail. We negotiated with our telephone provider to reduce costs so that inmates could stay in contact with their loved ones. Administrative staff worked remotely for a number of weeks. We are constantly re-evaluating and modifying our safety measures as the pandemic continues to affect our daily operations.

#### **Law Enforcement**

The patrol division is comprised of 11 rural patrol Deputies. Through funding from the State of Maine, we have one Deputy dedicated to patrolling the unorganized townships. The patrol division is overseen by a Lieutenant. The Detective division is comprised of three Detectives and is overseen by a Lieutenant. The Sheriff's Office continues to partner with MDEA (Maine Drug Enforcement Agency) to have an agent assigned to the Detective division.

The patrol division now has a trained drug recognition expert, a State certified accident reconstructionist, and 2 forensic mappers.

The Sheriff's Office has 4 Deputies assigned to Madison along with a Secretary/Dispatcher.

In 2020, the Sheriff's Office had 1 Deputy graduate from the Maine Criminal Justice Academy, Deputy Hunter Howard. Due to the Covid-19 pandemic, a portion of his training was done remotely, and it took a substantial amount of additional time for him to complete the course studies.

Throughout 2020, the Sheriff's Office Criminal Division investigated a large volume of illicit drug trafficking activities and obtained and executed numerous drug search warrants, which subsequently led to the arrest and conviction of numerous people from Maine and out of State on various Federal and State level drug trafficking charges. Large amounts of illicit drugs, to include heroin, fentanyl, crack cocaine, cocaine, crystal methamphetamine, and controlled pills were seized, along with thousands of dollars in illicit drug proceeds, several motor vehicles and firearms. The Criminal Division investigated numerous serious felony level cases to include robberies, burglaries, thefts, scams, aggravated assaults, unattended deaths and sexual abuse cases.

In 2020, the Crimes Against Persons Detective investigated 30 sex crimes. 13 of those cases involved child sexual abuse where forensic interviewing was utilized. Detective Jeremy Leal is a Children's Advocacy Center forensic interviewer. The Sheriff's Office Criminal Division tracked 54 individuals who are required by law to register as sex offenders, and 3 individuals were arrested for failing to register with the Sex Offender Registry.

#### Jail

The Somerset County Jail, when operating at full capacity, operates with 36 budgeted Correctional Officers, 8 Shift Supervisors, 2 cooks, 12 program and support staff, and 9 administrative staff to include Major Cory Swope, who is the Jail Administrator.

- The County Jail is now 13 years old. We are projecting the Jail bond will be paid off in 2028.
- The County Jail is nationally accredited through the American Correctional Association and is operating
  under nationally accepted best practice standards. The County Jail is also PREA (Prison Rape Elimination
  Act) certified.
- In 2020, the Somerset County Jail processed 1,193 bookings, a 23.8% decrease from 2019.
- In 2020, a significant amount of time and resources has been dedicated to extensive modification of
  operations related to the Covid-19 pandemic.
- Our federal inmate boarding contract was renegotiated to include an increase in our per-day reimbursement rate to house federal inmates.
- Our partnership with Redington-Fairview General Hospital and their Rural Communities Opioid Response
  Planning grant consortium has led to Redington-Fairview General Hospital being awarded a 3-year
  implementation grant. Through this grant, the Jail will receive funding to contract for the services of a Case
  Manager to work specifically with our inmate population that identifies as having a substance use disorder
  in an effort to combat recidivism. The Case manager will work closely with Redington-Fairview General
  Hospital and other care providers to continue to provide treatment and programming initiated in the Jail for
  offenders after release.
- The County Jail continues to actively recruit qualified Corrections Officers to join our professional and dedicated team.

#### **Civil Process**

In 2020, the Somerset County Sheriff's Office Civil Deputies received 1,193 papers to process and serve. That is a 30% decrease from 2019.

#### **Calls for Service**

- In 2020, the Sheriff's Office received 14,521 calls for service from our residents. This represents a 3.8% decrease over 2019.
- During 2020, the Sheriff's Office responded to 453 calls for service from the Town of Athens, which is a 10.5% decrease over 2019. These calls included 10 motor vehicle stops, 53 motor vehicle accidents, 14 calls requesting citizen assistance, 7 domestic disturbances, as well as calls for the ft, criminal threatening, assault, harassment, welfare checks, and requests for other police services.

The Somerset County Sheriff Office remains committed to our core values: INTEGRITY-RESPECT-FAIRNESS-DEDICATION.

#### 2020

#### SELECTMANS REPORT

The year of 2020 was one like our Town has most likely never seen before. Fortunately we were able to have our March Town Meeting however things changed soon after with meetings and office hours across the state being reduced or canceled all together. Despite the situation our town business went on with as much normalcy as possible with everyone doing their best to get done as much as could be done considering the situation. Our Town Clerk, Tax Collector and Treasurer came into the office every week and despite often times not getting answers needed from other sources went above and beyond to do what was needed to keep things going.

We were able to complete some projects such as purchasing new office computers and computer upgrades. Our Town website is now up and running and can be accessed at <a href="www.athens.maine.gov">www.athens.maine.gov</a> we hope you visit and offer suggestions.

We were able to complete the Gazebo Project and have an article addressing repairs on the Exhibition Hall in this year's warrant. Due to the covid situation were not able to complete the annual town audit however that is currently being completed. Town roads as mentioned elsewhere in this report consume a large part of our total budget and are a yearly challenge we are working on a town wide upgrade plan. Our school is also scheduled for partial makeover and its hoped that project will be completed this year.

Due to an increase in the selling prices of homes and land here in town the States valuation of our Town has significantly increased over the past few years. This increase effects all the revenues we receive from the state and its imperative that in order to receive as much as we are eligible for that our local valuation is as close as possible to that of the states. We may be facing a revaluation of some type to stay in step.

Overall our town is in good financial standing and the Selectman will continue to balance the towns interests in a way that meets everyone's needs .

#### CHANGES AROUND TOWN

One thing in life that is certain is that change is inevitable and we had change in our Town in 2020. At the 2020 Town Meeting it was voted to raise \$6000.00 to make repairs to our Gazebo which in the past was also known as The Band Stand. The Gazebo had become unsafe was hard to access by some and it was feared it might fall off the wooden piers it rested on. Our Town Road/Town and Grounds crew tackled the project and worked off and on through the summer pouring a concrete pad, rigging and lifting the building off its piers and set it onto its new foundation complete with a new cedar flag pole which was a near identical duplicate of the 100+ year old pole that was there. The whole project came in at just about \$6,000.00 which was half of the estimate given to us by an outside firm. We feel the project was a great success and the building is safer, more accessible and hope to see it used more in the future.

Many remember the old Post Office on Main Street which also doubled as Jim Scotts General Store. This past summer the building which was unused ,unsafe and had fallen into disrepair was purchased by River of Life Christian Fellowship who also purchased the Goods From The Woods Building next door. The decision was made to tear the old Post Office down and there are plans to improve the whole area and we are told good things are coming so stay tuned.

It's not recent news but we came across this picture of The Dr. Ellingwood Estate from years ago, it was a beautiful set of buildings. Its where our School is located and shows us the changes that can take place in a 100 year time span.

2020 was a year like no other in recent memory and bought changes in the way we lived our daily lives and affected how we did most everything. Here is a picture of our Official Ballot Drop Box the first of its kind. Its meant to be used by voters who were not able to drop off absentee ballots during regular office hours. The 2020 election saw a pear record voter turnout here in Athens.

Another change in our Town was the addition of a new business at 23 South Main Street. Landlubbers Grill and Dairy Bar officially opened in early summer and is a welcome addition to the whole area.

The Country Store which was more recently Lou's Dinner was purchased by the Bartlett's and we are told there are plans for a new business there.

We will most probably see more changes in the near future and feel that change will be positive and value input from our community on how that change will happen.

## TRANSFER STATION REPORT

For the 2020 year we budgeted \$ 60,000.0 for Muncipal Waste which includes disposal of trash, demolition, container hauling, container rental, and licensing fees. We spent just over the \$60,000 and will need to budget slightly higher for 2021 due to increased tonnage and fee increases from Waste Management. (see the Waste Management notice). The amount of trash was up by 28 tons and demolition was down several tons. We encourage everyone to seperate out metal and dispose of it into that container as well as other recycables such as some plastics, cardboard, electronics ,batteries, thermostats and paint containers. Most of these are free of charge but there may be fees for some items check with the attendant. Also returnable beverage containers can be put into the horse trailer those procedes as well as items placed in the Give and Take go to our school for use on such things as field trips. The Transfer Station Portion of the budget which includes wages, and miscellaneous costs was budgeted at \$14,500.00 and came in under budget and will remain the same for 2021. The Selectman would like to thank Steve Allen for keeping things up and running every week of the year.

You may have noticed a clothing bin at the Fairgrounds placed there by Apparel Impacts. Apparel Impact is a Family and Veteran Owned and operated business that focuses on the recovery of textiles and the support of communities throughout the country and is a highly regarded recycling company that truly understands the value of giving back and supporting their communities while having a primary mission to reduce waste and improve the environment.



Nearly 10% of all trash in local landfills are textiles. Apparel Impact provides towns and municipalities the opportunity to reduce their landfills of textiles and recover them, reducing landfill waste and reducing towns overall budgets spent on the disposal of textiles. ## ROADS REPORT

Town Roads consume a large part of our annual budget. For 2020 we budgeted \$221,500.00 which includes summer and winter roads, equipment maintenance, salt and sand,brush cutting and roadside mowing. In addittion we budgeted \$50,000.00 to go into the paving account and \$53,843.40 to pay on the Roads Bond bringing the total to over \$325,000.00 which for 2020 was nearly 45% of our total budget. We actually came in under budget on summer roads, winter roads and the salt and sand account however the equipment maintenance portion was over budget. All of our equipment is at least 20 years old upkeep is exstensive and exspensive, fortunately we have an good crew when it comes to repairs and they keep everything moving.

Winter roads as always are a challenge ice storms are more frequent causing the need for addittional salt and sand. Traffic at all times of the day and night is a common occurence, we have a prioritized list of when each road is plowed and sanded if special attention is needed contact our crew we will try to get to it asap.

A goal for the coming year is to do more roadside brush cutting its been a number of years since thorough brush cutting has been done. Once the brush is gone we can start ditching and begin adding gravel.

We need to do some work on The Town Garage the roof is leaking and wind has lifted the ridge cap. We hope to do some work to the old Town Garage such as repair the roof and siding and perhaps replace the doors that were taken off years ago. The building is old but serves a purpose and would be exspensive to replace.

Overall we are confident that the money we appropriate is spent wisely and road improvements are happening.







# **Town of Athens**

In accordance with Title 36, Section 706 of the Maine Revised Statutes, The Athens Board of Assessors hereby gives notice to all persons liable to taxation in Athens to file lists of their real and personal property with the Board of Assessors by Tuesday, March 30, 2021. The Board of Assessors will be in session from 7:00PM to 9:00PM for the purpose of receiving such lists. Lists may also be sent to the Town of Athens, Board of Assessors, P.O. Box 146, Athens, Me. 04912. Under such notice, taxpayers failing to furnish lists of taxable property on or before March 30, 2021 jeopardize their right of any abatement of taxes.

# **Notice to Athens Residents**

Any veteran who will be 62 years old on or before April 1, 2021 or any Veteran who is 100% disabled may be entitled to property tax exemption. You must have served during a wartime period to qualify for the exemption: also, any unmarried widow or widower of a veteran that meets the requirements may be eligible.

Anyone who is not already receiving a property tax exemption, but feels they would qualify should contact the Athens Assessor's office either by mail (P.O. Box 146, Athens, ME 04912) or phone (654-3471).

# The Maine Homestead Exemption

Possible tax Relief for Maine Homeowners. The Maine Homestead Exemption may lower your property tax bill. It makes it so the town won't count \$25,000 of value of your home for property tax purposes. You can qualify if you have owned your home in Maine for at least 12 months. Contact the Town Office for forms or more information.

# Greetings:

In the name of the State of Maine, you are hereby requested to notify and warn the Inhabitants of the town of Athens, in said county, qualified by law to vote in town affairs, to meet and assemble at the Athens Somerset Academy, in said Athens, on Friday the 12th of March, 2021A.D. at four o'clock in the afternoon to elect all Town Officers. The transaction of other town business will be conducted on Saturday the 13th of March 2021 A.D. at the Athens Community School at 1:30 in the afternoon as herein enumerated in the Articles of the Town Warrant. For the election of officers, the polls will be open after the election of a moderator, and will remain open until 8:00 in the evening.

- Art. 1. To choose a Moderator to preside at said meeting.
- Art. 2. To elect town officials.
- Art. 3. Shall the town vote to accept funds as provided by the Maine State Legislature

State Municipal Revenue Sharing.
Highway Maintenance Funds.
Tree Growth Reimbursement Funds.
Veterans Reimbursement Funds.
Support of the Poor Reimbursement Funds
Snowmobile Registration Refund Funds.
Homestead Exemption Reimbursement Funds
Any state grants that are made available by the State.
